(15)The description that on many of the battles on the Ultimate Rap League YouTube channel reads in pertinent part, "FOLLOW THE MOVEMENT @BEASLEYNYC @URLTV @SMACKWHITE @STREETSTARNORBES @THISISTWIZZ @RAIN910 @BELIKEIKE @NUNU NELLZ @WEGOHARDTV @PSWISS300 @EBLTV @PAPILAPUGH[.]" The section entitled "About Ultimate Rap League" reads as follows: "URLTV, also known as Ultimate Rap League, is the home of smack URL on YouTube and the world's largest platform for the MC Battle Culture. You'll find URL Rap Battles vs Tay Roc, Tsu Surf, Chess, Charlie Clips, Brizz Rawsteen, Rum Nitty and many more!"

- (16)In the earliest years of the company, ticket sales from the live events were the primary source of revenue for the Ultimate Rap League. The income from the live events was supplemented by the Ultimate Rap League's YouTube revenue. However, in 2015 the primary source of revenue would shift to payper-view events on WatchBattleLive.com (\$40 - \$50 per event) and then to the URLTV mobile application (also referred to as the "URLTV App"). The URLTV App is a subscription-based platform (\$7.99 per month) that was released in 2019.
- (17)From 2009 to 2020, Plaintiff, as a partner, executed many activities that include but were not limited to, the following: recruiting talent (on-screen and support staff), engaging in promotions, hosting battle rap events, organizing

battle rap events, executing contracts, raising capital, and developing business concepts for the Ultimate Rap League.

- (19)From 2009 to the present, the Ultimate Rap League has not held a single battle rap event without any of the talent acquired by Plaintiff.
- (20)From 2009 to the present, the Ultimate Rap League held events domestically and internationally, and Plaintiff was instrumental in executing these events.
- (21)The events detailed in this Complaint are some of the events held by the Ultimate Rap League from 2009 to the present.
- (22)The Ultimate Rap League held its first event on or about Saturday, October 31, 2009, which was hosted by Troi Torain a/k/a "STAR," a popular media personality. - (220)On or about Saturday, September 28, 2019, the Ultimate Rap League hosted an event entitled "Born Legacy 8" in Cleveland, Ohio. The battles from "Born Legacy 8" were uploaded to the URLTV App.
- On or about Tuesday, October 1, 2019, the Ultimate Rap League hosted (221)an event entitled "Survivor Series NY: The Return."
- (222)On or about Saturday, October 5, 2019, the Ultimate Rap League hosted an event entitled "Road to Traffic 4" that featured the main event battle between "Stuey Newton" and "Danny Myers."
- (223)On or about Sunday, October 6, 2019, the Ultimate Rap League hosted an event entitled "Lockdown" in Philadelphia, Pennsylvania. The main event battle was between "Cassidy" and "Arsonal."
- (224)On or about Tuesday, October 8, 2019, the Ultimate Rap League had its talent featured at the 2019 BET Hip Hop Awards, which aired on Black Entertainment Television (BET). - On or about Saturday, December 7, 2019, the Ultimate Rap League (227)hosted an event entitled "Gridlock" at Bruddahs Bar & Grill in Gardena, California. The main event battle was between "Hollow da Don" and "Danny Myers."
- On or about Sunday, December 8, 2019, the Ultimate Rap League hosted (228)an event entitled "Traffic: Charity Event" at Los Globos in Los Angeles, California.

(232)On or about Saturday, January 25, 2020, the Ultimate Rap League began a two-day event, "URLTV App Private Event 1." The battles from this event later appeared on the URLTV App.

- (233)In February 2020, Defendant Ultimate Rap League, LLC, announced its partnership with world-renowned recording artist, Aubrey "Drake" Graham and Caffeine, Inc., to supply battle rap content on Caffeine's social broadcasting platform.
- (234)On or about Friday, February 28, 2020, while Plaintiff was interviewing another battle rapper, "Rum Nitty," he was attacked by Raivon Anderson a/k/a "Nu Jerzey Twork." The incident was captured on video by an eyewitness and uploaded to various social media platforms, and Plaintiff was subjected to harassment by the battle rap community. Defendants were aware of the incident and its presence on different social media platforms.
- In a YouTube video uploaded on the Ultimate Rap League channel, on (235)February 29, 2020, entitled: "Genesis: Smack and Beasley discuss Caffeine Partnership | URLTV," Defendant Mitchell and Defendant Beasley talked about Caffeine and the URL.

Professional football player Gerald McCoy attended this event after being invited by Plaintiff (this occurred before he was attacked by "Nu Jerzey Twork"). Caffeine experienced technical difficulties with the amount of traffic that it was receiving during this event.

- Shortly after the incident, Defendants Troy Mitchell and Eric Beasley (237)explicitly stated that there would be some disciplinary action taken against "Nu Jerzey Twork" for the incident with Plaintiff. To date, Plaintiff does not know of any disciplinary action levied against "Nu Jerzey Twork." Shortly after attacking Plaintiff Velez, "Nu Jerzey Twork" would be featured in a battle during the series entitled "Quarantined" during the COVID-19 pandemic.
- (238)On or about Saturday, March 14, 2020, the Ultimate Rap League began a two-day event, "URLTV App Private Event 3." The battles from this event are being released on the URLTV App.

- Beginning around 2015, at the demand of an outside investor known as (252)"Harry," the Ultimate Rap League began showing battles on pay-per-view through the WatchBattleLive.com platform, a platform owned by "Harry." "Harry" had previously made several investments into the Ultimate Rap League over the years and would continue financing events for the Ultimate Rap League in the future. "Harry" has been publicly acknowledged by Defendants Troy Mitchell and Eric Beasley, along with some battle rappers.
- (253)Plaintiff managed and controlled the Proving Grounds talent developmental system of the Ultimate Rap League.

balance of their compensation the day of the event. As the years progressed, the contracts became more sophisticated, including payment covering multiple performances, which could span several months or at least a year.

- (257)The compensation for the battle rappers of the Ultimate Rap League ranged from approximately \$1,000 per battle for the emerging talent identified as "Proving Grounds battlers" or "PGs" to as high as roughly \$90,000 (single battle or multiple battles) for the so-called "Top-Tier battler."
- (258)Plaintiff would share profits, when made available, from some of the URL events, more specifically, "Born Legacy" and "Proving Grounds" events, with Defendants. Plaintiff distributed profits to Defendants in cash.
- (259)Plaintiff is a significant contributor to the Ultimate Rap League, reaching over 1 million subscribers on YouTube, getting exposure on national television, and landing its deal with Caffeine, Inc.
- (260)Plaintiff never received a contract, in writing, for the plethora of services that he was providing to the Ultimate Rap League or a written employment agreement from the Ultimate Rap League.
- (261)Plaintiff often appeared on camera to represent the Ultimate Rap League on various media platforms.
- (262)Plaintiff's image and likeness often appeared on advertisements and videos for the Ultimate Rap League.

- (265)Plaintiff, with the knowledge and consent of the Ultimate Rap League, used his bank accounts to pay for expenses of the Ultimate Rap League.
- (266)Plaintiff and Defendants Troy Mitchell, Eric Beasley, and Jean French verbally agreed to be partners of the Ultimate Rap League.
- Plaintiff was not the custodian of the financial records of the Ultimate (267)Rap League.
- (268)Plaintiff's name and likeness continue to appear in many videos currently on YouTube on the official Ultimate Rap League channel and other digital media platforms.
- (269)Plaintiff is an integral part of developing the Ultimate Rap League into becoming "The World's Most Respected MC Battle Arena."

- (279)Defendants released false statements to third parties that Plaintiff was fired as an employee and no longer involved and doing business on behalf of the Ultimate Rap League.
- (280)Defendants knew that at no time since the start of the Ultimate Rap League in 2009, did the partners ever represent Plaintiff as anything but a partner in the URL.
- (281)Over more than a decade with the Ultimate Rap League, Defendants never presented an IRS Form W-2 or IRS Form 1099 to Plaintiff.
- (282)Defendants' statements were made by Defendants with the sole purpose of defrauding Plaintiff.

- (287)Plaintiff adopts by reference the allegations contained in paragraphs one through 286 of this Complaint with the same effect as if herein fully set forth.
- (288)For over ten years, Plaintiff made a statement to Plaintiff and third parties that Plaintiff was a partner of the URL.
- (289)Defendants had a duty of care to Plaintiff. This duty of care required Defendants to provide Plaintiff with an accurate splitting of profits and the transmittal of the correct URL information to partners and third parties.
- (290)Defendant was negligent in its actions by not properly splitting profits and by telling Plaintiff he was a partner when he was not.
- (291)Defendants intended for Plaintiff to rely on these assertions and to produce content, obtain sponsorships, and aid the URL in building contacts within the battle rap and business communities.
- (292)Defendants knew that Plaintiff would rely on the statements.
- Plaintiff's actions include borrowing funds, getting sponsorships, (293)helping the URL with national placement on syndicated cable television, and building more than 80% of the URL talent. Plaintiff was justified in reliance

- (294)As a result of the conduct of negligent misrepresentations by Defendants, Plaintiff incurred damages.
- WHEREFORE, Plaintiff demands judgment against Defendants in the (295)amount to exceed \$500,000, with interest and costs.

#### **COUNT FOUR**

# (Breach of Fiduciary Duty)

(Troy Mitchell, Eric Beasley, Jean French)

- (296)Plaintiff adopts by reference the allegations contained in paragraphs one through 295 of this Complaint with the same effect as if herein fully set forth.
- (297)Plaintiff Velez, Defendant Mitchell, Defendant Beasley, Defendant French, and Defendant Mitchell were engaged in a partnership to grow the battle rap business known as the Ultimate Rap League. This firm has been involved in the battle rap business for over ten years.
- (298)Plaintiff Velez and Defendants shared profit and losses on an equal basis and, over the past ten years, worked together in the business of battle rap, developing a prestigious league known for its excellent work.
- (299)Before February 11, 2020, Defendants were in negotiations with Caffeine, Inc., an organization that produces digital content and garners streams to its website. Caffeine invited Defendants to partner by creating

battle rap content through the URL that would become the anchor programming of Caffeine's streaming application.

- Defendants and Caffeine discussed, over at least six months, the (300)affiliation of URL with Caffeine and Defendants' ability to, among other things, recruit battle rappers, develop talent, and produce battle rap content for the Caffeine platform.
- (301)Defendants did not disclose any of these discussions to Plaintiff Velez. However, Defendants did approach several battle rappers, many of whom were initially brought to the URL by Plaintiff, and without disclosure to Plaintiff, solicited the services of the battle rappers for Caffeine when Defendants knew they would try to dissolve the relationship with Plaintiff.
- (302)Defendants also poached content that was created by Plaintiff, much of the content Defendants rejected in partner meetings, used the ideas to pitch to Caffeine as added value for Caffeine's application, even though Defendants undermined and suppressed the contributions of Plaintiff.
- (303)Defendants and Caffeine, Inc., in February 2020, completed and announced a partnership in which the URL would supply content for Caffeine.
- (304)In April of 2020, Defendants notified Plaintiff Velez via a public statement that Plaintiff no longer had any affiliation with the URL.
- (305)Defendants, as partners to Plaintiff Velez, were accountable to Plaintiff as fiduciaries. As partners, Defendants owed Plaintiff and the partnership the duty of loyalty and good faith, without any self-interest or self-dealing.

(306)Defendants breached their fiduciary duties to Plaintiff Velez by secretly taking Plaintiff's ideas for content and presenting it in negotiating the deal with Caffeine, soliciting and securing the services of battle rap talent to perform on the Caffeine platform, and putting out a statement stating Plaintiff Velez was no longer involved in any capacity with the URL.

- By Defendants' breach of their fiduciary duties owed to Plaintiff, (307)Plaintiff suffered damages.
- (308)WHEREFORE, Plaintiff Velez demands judgment against Defendants in an amount to exceed \$500,000, with interest and costs.

## **COUNT FIVE**

# (Breach of an Oral Joint Venture or Partnership Agreement) (Troy Mitchell, Eric Beasley, Jean French)

- (309)Plaintiff adopts by reference the allegations contained in paragraphs one through 308 of this Complaint with the same effect as if herein fully set forth.
- (310)Plaintiff and Defendants in October of 2009 had an oral agreement to partner to form the Ultimate Rap League.
- Plaintiff organized battle rap events, and he was present at several (311)different events during this time.
- Before 2009, Defendants were not putting on rap battles in a "versus" (312)competitive format as an organization.

(313)Around 2003, Troy Mitchell recorded content and released the recorded footage on DVDs known within the hip-hop industry as "SMACK DVDs." Some of the DVDs had rap battles, although this was not the primary focus of the DVD series. The first battle appeared on "SMACK DVD Vol. 3," a battle between Jarvis Mills a/k/a "Jae Millz" and Sharod Sims a/k/a "Sire Castro" hosted by Sean "P. Diddy" Combs. The battles in the series would become

- (314)Troy Mitchell wanted to produce SmackTube, with the help of Plaintiff, but due to Defendant Mitchell's lack of resources in the battle rap community and lack of funding, SmackTube was an epic failure.
- (315)Around 2009, Eric Beasley worked as an Artists and Repertoire (A&R) for Asylum Records in New York, NY.
- (316)Around 2009, upon information and belief, Jean French, known as "Cheeko," was a music producer and computer technician.
- (317)While Defendant Beasley was employed by Asylum Records, Plaintiff, Defendant Beasley, and Defendant Mitchell would have regular meetings at Atlantic Records found at 1290 6th Avenue, New York, NY 10104, to conduct the business of the Ultimate Rap League. Defendant French would be absent from specific meetings because of schedule conflicts.
- Plaintiff was the manager of "Math Hoffa," who was considered one of (318)the best battle rappers at the time, and some regard today as a legend.
- (319)Before 2009 there was no Ultimate Rap League.
